## Knight Campus Phase 2 impacts – Haily

- The Knight Campus Phase 2 construction begins on December 12, 2022 and will continue through 2025.
- Millrace garage and surrounding areas will be impacted by the construction.

#### E-bike & E-scooter parking and charging on campus – Haily
