 Incident was due to a table from an equipment rental company with a damaged table being used.

New Business

- Shelly Clark - Threat Assessment and Cleary Co-Ordinator will speak. What she does, BETA team, resources on campus about proactive personal safety.
 - Behavioral Evaluation and Threat Assessment is a process to help committee/others to identify students/employees that need help. Community

Care and Concern Form open to submit any concerns at any time related to students/employees. This is auto-routed to the appropriate group to direct response. BETA team assesses risk of physical violence based on threats and provides safety planning and work in conjunction with the Student Care Team in these situations.

- Review of the possible factors contributing to or helping the behavior and the process toward escalation and de-escalation.
 - Review of social media safety and how online presence may affect visibility to possible threats to safety.
 - Review of Safety Planning resources on campus like safety escorts, Duck Rides, vacation watch, etc. This includes resources posted online.
 - Shelly opens the floor to questions. Committee member notes that they have used this process before and underscores the depth of resources and support provided. Committee member asks if they could set up a larger group meeting for questions to help conserve time.
2. December meeting moved forward a week to the 18th.
 - No concerns noted about the change.
 3. Monthly Safety Training - Justin
 - Training today at EMU about Safety in Office Environments and room is available still. Purpose is to touch on injuries that happen to roles that typically are not safety focused. December is GHS training and Ladder Safety training. Safety Sheets will address December weather, Severe Weather and Cold Stress.
 4. Waddle and Wheel cards printed and received – ask for them if wanted by committee members – Ruby.
 - Available to committee members in both physical copies and digital copies for screens across campus.
 5. Safety Shout Out, open the floor to committee members new business.
 - Shout Out to Haily for always being available to help and taking calls.
 - Shout Out to members of committee who attended OSHA 30 training.
 - Committee member asks about first aid kits and eyewash stations on PDX campus. Planned safety training in-person up there soon to address these and more.
 - ESPN College Game Day is happening this week, goal of the safety department to block off the area for forklift work related to this. ADA Access involves safety escort to get into Condon.
