SAFETY RULES

1. Operation must be in a manner that does not endanger passengers, students, employees, the public and other members of the University community, or property.
2. Operation may not impede or interfere with normal pedestrian, bicycle, or vehicular traffic.
3. Operators may not exceed posted speed limits.
4. Operators must reduce vehicle speed on sidewalks and pedestrian areas and may not operate at a speed greater than pedestrian traffic.
5. Pedestrians have right of way at all times. Operators may not pass moving pedestrians without their acknowledgement.
6. Golf cart/utility vehicles must remain at least 2 vehicle lengths behind pedestrians.
7. Use of cell phones or other mobile devices is prohibited while driving.
8. Use of hearing impeding devices, such as headphones and ear buds, is prohibited while driving.
9. All occupants in golf cart/utility vehicles equipped with seatbelts must wear seatbelts.
10. All occupants must be in seats. Bench seating is limited to 2 persons unless otherwise stated by manufacturer.
11. The number of passengers and load capacity shall not exceed the vehicle manufacturer's rated limit.
12. Materials or equipment must be loaded and secured as necessary to prevent a hazard by shifting or falling off.
13. Golf cart/utility vehicles may operate only on approved streets and routes as designated on the Golf Cart/Utility Vehicle Routes map.
14. Operation is not permitted on landscaped areas, sidewalks, city bike paths, city bike lanes, Autzen Foot Bridge, Franklin Blvd, or streets where the posted speed limit is above 30 mph.
15. Golf carts/utility vehicles must travel on approved streets until the closest approved sidewalk or path to final destination is reached, at which time travel can proceed onto sidewalks/paths for the final portion of travel.
16. Operators must avoid driving on the closed portion of 13th Avenue during class change.
17. Operators must conduct a daily pre-shift inspection of vehicle prior to use to ensure equipment is working properly. If any of the following equipment is not working properly, operation of the golf cart/utility vehicle is prohibited.

a. Headlights/taillights/turn signals	c. Brakes
b. Horns	d. Adequate fuel or charge
