Ergonomics in Office and Laboratory Settings

Offices and labs have unique ergonomic challenges; we often work in static and sometimes awkward positions for extended periods of time. Our ergonomic coordinator, Michelle Gillette, has performed assessments and provided training for employees in many different positions at the university, including labs and offices.

Take a moment to think about how you work. Are you reaching away from your body to use your keyboard or looking up at your monitor? Do you work at a lab bench or a microscope and find you are hunched over? These positions can be uncomfortable and over time may even be painful. Sometimes an adjustment of your chair/stool or the height of your monitor or microscope can help. See the information below to request an assessment from our experts.

One option now available for office assessments is <u>Ergopoint</u>. EHS has partnered with SAIF, the UO's workers' compensation insurer, and <u>Humantech</u> to use this program. Ergopoint is a web-based office ergonomic training and self-assessment tool.

To use Ergopoint, enter your information under Request an Assessment on our Ergonomics web page. We will email you intormation to log into and use your Ergopoint account. While you are on the Ergonomics web page, be sure to take a look at the *Information and Resources*. You will find some helpful links for general, laboratory, and office ergonomics.

Did you know that EHS has an ergonomic lending library with items available for trial use for up to 30 days? You can borrow chairs, height-adjustable desktop workstations, keyboards, ergonomic pointing devices (mice) and more. To find out what's available go the Ergonomics webpage. This is also where you request item(s) to try out (click on Request a Lending Library Item).



EHSA updates

Our EHS Assistant software has a new look and several new features. In addition to submitting waste pickup requests, users can now create their own accounts, see their training records, request waste supplies be delivered, and more—all by logging in with your Shibboleth credentials.

Additionally, PIs and lab managers can view EHS inspection results, respond to inspection findings, and check their lab members' training records

Chemical inventories are uploaded into EHSA by EHS staff using an Excel spreadsheet template.
Once uploaded, lab members can then add or delete chemicals from their inventory.

FYI: Volatile odor noticed during City sanitary sewer sampling 10-22

The City of Eugene sampled at the LISB manhole and noticed a distinct volatile organic odor around 10:45am on Oct 22nd. The sample appeared clear and had a neutral pH. The EHS Chemical Safety Officer conducted a comprehensive review of research lab spaces for any unusual discharges, which may have taken place throughout LISB. EHS findings inconclusive on the source of odor and follow up communication with the City sampling team was completed.

Just a reminder: lab wastes are collected by EHS. Please be mindful of what substances are discharged down the lab sinks. Refer to the Lab Safety Manual for reference. Besides being bad practice, infractions can result in fines and unwanted public relations. We are in this together! Please do your part by having EHS pick up lab wastes. Questions? Reminder: Recycling corrugated cardboard boxes is the responsibility of individual labs.

Cardboard boxes are to be flattened completely and placed in green recycling carts located at loading docks by Streisinger, Onyx, and the east side of Pacific. Avoid accumulating cardboard in the labs spaces or hallways as this is a fire safety issue. Also, do not place cardboard in the hallways near campus recycling cans in hopes that it will just disapppear. Cardboard does not go away by itself, it needs your help.
