

## **Clery Act**

In 1990 the federal government enacted the Jeanne Clery Disclosure of Campus Security Police and Crime Statistics Act (Clery Act), which any college or university that receives federal student financial aid to report certain crime statistics, issue campus alerts, and provide a detailed annual security report, among other compliance requirements. clery.uoregon.edu

## **CLERY ACT COMPONENTS:**

**Campus Security Authorities:** CSAs are employees who are in a professional position that makes it likely that students or others could report crimes to them. Under federal law, CSAs have a responsibility to tell the institution about such incidents. clery.uoregon.edu/campus-security-authorities

**AnnualSecurityReport:**The ASR is released annually by October 1st and can be found at *clery.uoregon.edu/annual-campus-security-and-fire-safety-report* 

**Crime Alerts** The University of Oregon sends out two types of alerts that satisfy Clery Act requirements to keep the campus informed about safety and security threats: "timely warnings" and "emergency notifications." *clery.uoregon.edu/crime-alerts* 

Clery ActMandatory ReportingThe Clery Act is a federal law that requires schools to collect information on and report crimes that occur at certain types of locations, including crimes that occur during student trips. clery.uoregon.edu/student-travel-requirements

Daily Crime Log In accordance with the 1998 Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, an electronic version of the Daily Crime Log is posted on our website and also made available, in hard-copy format, to walk-in customers in the front lobby area of the University of Oregon Police Department (UOPD).clery.uoregon.edu/reports/crime-log

## **REPORTING A CRIME:**

- By Phone For emergencies, life-threatening situations, or crimes in progress, call 9-1-1.
- For non-emergency assistance and information on campus, call the UOPD at 541-346-2919
- For off-campus non-emergency assistance or to report past crimes, call Eugene Police 541-682-5111, or Springfield Police at 541-726-3714.
- In Person You may make a report at the UOPD Station, 2141 E. 15th Ave. in Eugene. After hours, call 541-346-2919 and let the dispatchers know that you would like to come to the station to make a report, so that an officer can be present to let you in.
